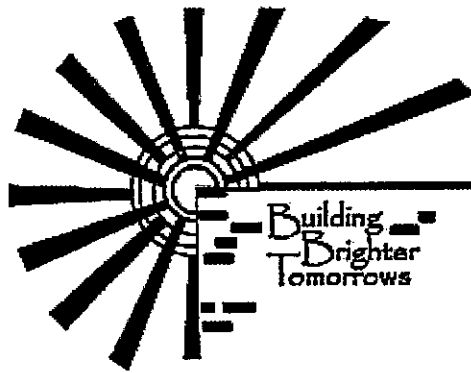

Economic Interest Statements were distributed.

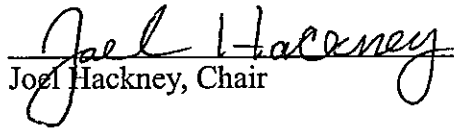
Discussed the Needs Assessment and the District Completion of the FY 2026 IDEA Part B Flow-Through and Pre-School Grants Consolidated District Plans.
